## MAINTENANCE AND LANDSCAPE PROJECTS

End of year landscape and maintenance projects were completed in October and early November.

Several trees had been damaged by wind or had just not thrived. Several trees were replaced in the north part of the commons with aspens and a river birch. In the north part of the commons one failing tree was replaced with a honey locust.

You may have observed that some of the bushes were missing or just not thriving on the berms along Victory and Cloverdale. Our landscape company put in 45 burning bushes that will add more fall and winter color.

The paved path through the common area was also oiled and sealed.
